## **Report from the 6th National Student Conference “Youth for Security” Gorzow Wielkopolski, 12 April 2021**

### **Abstract**

The Conference was an opportunity for young scholars and students to meet and create a space for themselves to present their research pursuits. During the conference, issues related to broadly understood security were discussed. The 6th National Student Conference “Young for Security” was the sixth of the cycle of annual scientific meetings dedicated to this topic.

The 6th National Student Conference “Young for Security” took place on 12 April 2021. The project was organized by the Jacob of Paradies University (JPU) in Gorzów Wielkopolski, the Educational Center Lubusz Youth Academy of Security, Regional Center for International Debate, branch Gorzów Wielkopolski. The Rector of the Jacob of Paradies University in Gorzów Wielkopolski, Prof. Elżbieta Skorupska Raczyńska, took the honorary patronage of the Conference. Representatives of several scientific institutions, including the Jacob of Paradies University in Gorzów Wielkopolski, Military University of Technology in Warsaw, Kujawsko-Pomorska School of Higher Education in Bydgoszcz, Police Academy in Szczytno, The Academy of Land Forces General Tadeusz Kościuszko in Wrocław, State Vocational University in Włocławek, Kujawy School of Higher Education in Włocławek, took active part in the conference and discussion.

The aim of the conference was to analyze broadly understood security in the context of contemporary challenges in the internal and international arenas, and to create a platform for the integration of young people interested in developing their research pursuits. It was assumed that a space should be created for students,

in which they would share their knowledge and experience, and inspire each other to further research and education in the field of security.

## Conference program and proceedings

The conference was opened by the Vice-Rector for Education of Jacob of Paradies University in Gorzów Wielkopolski, Dr. Przemysław Słowiński and the Dean of the Faculty of Administration and National Security, Dr. hab. Beata Orłowska prof. AJP.

The conference program was divided into four thematic panels: threats in cyberspace, military formations in the security system, internal security, social security.

The first panel included the following speakers:

- **Dominik Szczepkowski**, Military University of Technology in Warsaw, Analysis of phishing methods in the time of the Covid-19 pandemic.
- **Krzysztof Dubaj**, Military University of Technology in Warsaw, Threats resulting from fake news in the time of the COvid -19 pandemic.

The second panel consisted of speeches delivered by:

- **Karol Wozikowski**, Jacob of Paradies University in Gorzów Wielkopolski, Actions of the Territorial Defense Forces in the fight against the coronavirus pandemic on the example of the 12th Wielkopolska Territorial Defense Brigade.
- **Aleksandra Betlińska**, Kujawy School of Higher Education in Włocławek, Territorial Defense Forces as the fifth type of armed forces.
- **Agnieszka Szewczuk, Monika Michalska**, Kujawsko-Pomorski University in Bydgoszcz, A sense of security during the Covid-19 pandemic during the training of the Academic Legion.

In the third panel, presentations were given by:

- **Dariusz Maciejewski**, Jacob of Paradies University in Gorzów Wielkopolski, The system of police negotiations in Poland.

- **Marcin Błażewicz**, Police Academy in Szczytno, Police forensic laboratories in the Polish criminal trial.
- **Jakub Lewandowski**, State Vocational University in Włocławek, Activities of the Border Guard as a guarantor of national security of the Republic of Poland.
- **Oliver Balogh**, Military University of Technology in Warsaw, The specificity of Hungary's national security strategy in the context of European security.

The last panel was attended by:

- **Krzysztof Zaborek**, Military University of Technology in Warsaw, Dangerous security - selected threats related to the sense of security.
- **Kacper Podgórski**, The Academy of Land Forces Gen. Tadeusz Kościuszko in Wrocław, Far-right terrorism - a challenge to security in the 21st century.
- **Katarzyna Kujawska**, Kujawski College in Włocławek, **Magdalena Klitkowska**, State Vocational University in Włocławek, Civilization diseases in the modern world
- **Monika Boniecka, Monika Piątkowska, Izabela Blankenburg**, State Vocational University in Włocławek, Shaping the attitude of social responsibility of an educator through student volunteering as a sign of social security.

The speakers addressed the issues of security in an interdisciplinary perspective. They emphasized the role of the state in creating social security conditions, and pointed to unfavorable phenomena affecting security, as well as to normative solutions being a tool for creating a secure country. The papers touched upon current security issues, organized crime, and a very important aspect: cybersecurity. The interdisciplinary character of the conference created a space for students to convey and share their knowledge, views and experiences.
