PROFESSOR KAZIMIERZ OBODYŃSKI AND HIS PATH OF FLEXIBILITY

ABSTRACT

Problem: Is it possible to apply the principles of martial arts in life, in professional practice, and in management? We will check it on the example of Professor Kazimierz Obodyński. **Method:** The author uses the method of participant observation (1987–2015), document analysis, and content literature analysis. **Results:** *Judo* practice took place, but essentially the path of "spiritual *jujutsu* and *judo*" was implemented, which was associated with management and activities in various scientific and social organizations. **Conclusions:** In the analyzed case of Professor Kazimierz Obodyński, applying the principles of martial ways in life, in professional practice, and in managing various institutions proved to be possible and effective.

INTRODUCTION

Prof. Dr. hab. Kazimierz Obodyński (21.10.1941–14.10.2015) is known mainly as a representative of physical culture sciences, a sociologist of

physical culture, a specialist in the theory of physical education, and the organizer of the institution of physical culture staff training. The year 2020 is the fifth anniversary of his tragic death and the fifteenth anniversary of the Faculty of Physical Education at the University of Rzeszow. By the way, the Faculty created by Kazimierz Obodyński has become the Institute of Physical Culture Sciences, which has only become a part of Collegium Medicum, since October 2019. Less known are Professor Obodyński's connections with the area of fighting arts.

In the first period of Obodyński's scientific activity (until his habilitation, i.e. the postdoctoral degree), the scientific achievements of this "father" of physical education in Podkarpackie region were focused on sociological studies of student physical culture. Later, mainly in cooperation with Wojciech J. Cynarski, he dealt with the socio-cultural research of martial arts and theory of tourism.² Both Obodyński and Cynarski have been working together, since 1992, in the European Association for Sociology of Sport (EASS), in the International Association for Physical Education in Higher Education (Association Internationale des Écoles Supérieures d'Éducation Physique, AIESEP), and in several other organizations. organized, among others the second EASS Conference; participated in numerous foreign international congresses and conferences; and since 2006, the Faculty of Physical Education of the University of Rzeszow has become an institutional member of AIESEP.³ Obodyński and Cynarski's joint idea was to establish IMACSSS – the International Martial Arts and Combat Sports Scientific Society.⁴

Is it possible to apply the principles of martial arts in life, in professional practice, and in management? The memory of Kazimierz Obodyński is here to be an occasion to reflect on this kind of martial arts practice. Participant observation method (1987–2015) was used as the main method in this article, as well as document analysis and content literature analysis.

PRACTICE IN MARTIAL ARTS

Kazimierz Obodyński successfully played rugby in his student years.⁵ It is a sport in some aspects related to combat sports. In addition, during his studies at the Warsaw University of Physical Education, the future professor also learned the basics of *judo*. As a sport-loving man and an activist of the Idokan Poland Association (IPA; Vice President for Science), he also undertook scientific reflection on the area of fighting arts.⁶ Combat sports are a discipline which in particular requires close cooperation with sports science (training and coaching) to achieve results and to protect players'

health.⁷ However, also in relation to non-competitive martial arts, science helps to solve many problems related to them: their use for recreation purposes, the motivation of exercisers, values related to them, their significance for identity and cultural dialogue, etc.

For his organisational activity, scientific work and supporting the community with his authority, the martial arts community awarded Professor Obodyński with master's degrees, with the right to a black belt in three disciplines of *budo*: *jujutsu*, *judo-do*, and *aikijutsu*. These are honorary degrees, respectively:

- 3 dan *jujutsu*, *Mukashi to Kindai* style/school, certificate signed by Dr. Jan Slopecki, 10 dan, *hanshi*;
- 2 dan *judo-do/ido* of *Idokan*, authorised by *meijin* L. Sieber, 10 dan and *shihan* W.J. Cynarski;
- 1 dan aiki-jujutsu Idokan, signed by Stanisław Cynarski, 9 dan, hanshi.

Professor Obodyński practically implemented the principles of "the art of flexibility", as the term *jujutsu* (Japanese *jūjutsu*) is translated. The principle of softness and flexibility (Japanese *ju-no ri*) is the first principle of combat tactics. One avoids fighting, especially direct collision. It is better to bend or adapt to the situation, like water adapts to the shape of the dish. Professor successfully used this "spiritual" *judo, jujutsu*, or *judo-do (judo* of the "extended way"⁸). He also obeyed the principle of social good, *jita kyoei*, present in the *Kodokan judo* tradition (Dr. Jigoro Kano's legacy).⁹

J*ujutsu* in the practice of management

Today's Japanese (and not only) businesspeople study the writings of the "sword's way" master Miyamoto Musashi, or use "negotiating *jujutsu*", including the "give way to victory" principle.¹⁰ The application potential of the "warrior's way" in various forms is enormous. For example, the principle of flexibility can be treated and analyzed as a tactical or a moral principle. Moral flexibility is questionable. Tactical one, on the other hand, is undoubtedly effective, at least from the perspective of pragmatism and praxeology. Avoiding extremes is consistent with both the Taoist pursuit of balance and the Aristotelian principle of moderation and that of the golden mean.

Obodyński was able to manage several institutions well, applying *jujutsu* principles. His skilful management practice translated into individual areas of the activity of the institutions he managed, i.e. the Institute of Physical and Health Education, and later the Faculty.¹¹ In addition to the principle of flexibility, the principle of *seiryoku zen'yo*, i.e. "economics in action" (minimum effort, maximum effect) applies to *jujutsu*-like management. Avoiding conflicts helped shape his good relations with various people and political forces. As the director of the Institute, and later the dean of the Faculty, Obodyński cooperated well with people with political views ranging from left to right, and with various environments (sports, local government, religious). One of his favourite reads was Mario Puzo's *The Godfather*. Hence, perhaps, his caution in conduct, and his search for beneficial relationships in various relational systems. These features of his can also be an echo of the teaching of Sun Zi master regarding, among others, acquiring allies.¹²

Even the very ability to maintain power in elective positions for a long time is in a way a proof of Obodyński's talents. It consists of psychological skills and the ability to manage teams of people. Obodyński was generally helpful for people, and he cared for the good of the institution for which he was responsible. He understood that people (the human capital) are

Support for martial arts institutions

Until his death, Professor Obodyński was the vice president of Idokan Poland Association (IPA), and in the years 2010–2014, he was also the vice president of the International Martial Arts and Combat Sports Scientific Society (IMACSSS). Thanks to it, it was possible for IPA and IMACSSS to organise conferences and congresses together with the Faculty of Physics of the University of Rzeszow.¹³ Obodyński's ideas and the functions he performed influenced the reality and image of both IPA and IMACSSS as scientific societies. In addition, he also participated in research projects of these institutions.¹⁴ He supported the organisation of events and subsequent publishing projects.

A number of IPA's projects were consulted with and accepted by Obodyński, as Vice President for Science and Chairman of the IPA Committee of Scientific Research. The content of one of the documents is presented in Appendix 1. It follows from this example that Obodyński's assistance did not go into details, and did not interfere specifically with the content of the research; he accepted the leading role of specialised committees and individual IPA experts.

Due to the support he provided to both scientific and sports institutions, including the already mentioned martial arts institutions, often during the lifetime of Professor Obodyński there were expressions of remembrance and gratitude towards him. He became a topic of a master's thesis¹⁵, several commemorative books – scientific monographs – were dedicated to him¹⁶, the largest auditorium at the Faculty of Physical Education UR has been

named after him¹⁷, and memories about him have been published on the websites of Idokan Poland Association and IMACSSS.

Conclusions

Although Professor Obodyński practiced *judo* (in his student years), in principle he followed the path of both "spiritual *jujutsu* and *judo*", which was about effective and long-term management and activities in various scientific and social organisations. At the same time, he implemented a specific form of *security culture*¹⁸, using principles of caution in operation and flexibility.

In the case of Professor Kazimierz Obodyński, applying the principles of martial arts in life, in professional practice, and in managing various institutions proved to be possible and effective. By the way, the Faculty of Physical Education at the University of Rzeszow was the first such university faculty in Poland. Professor also has had great merits for two martial arts scientific associations: IPA and IMACSSS.
